The ConsentCheq CDK facilitates the following activities required by the following Articles of the GDPR

GATHERING INFORMED CONSENT [ARTICLE 6](#)

- › Create “intelligible” privacy notices based on “blended approach”
- › Notices adapt to user’s device for best readability
- › No programming skill required to make privacy notices
- › Privacy notices delivered via web URL – easy to integrate into web, app, IoT
- › Standardized icons help communicate with data subjects

GATHERING CONSENT WITHOUT IDENTIFICATION [ARTICLE 11](#)

- › Nearly frictionless method of getting consent to collect data
- › Unidentified consent is logged
- › Users may maintain their consent later by providing identifiable information

RECORD CONSENT [ARTICLE 7](#)

- › The ConsentCheq API records customers’ consent
- › Custom events may be tracked through the API as well

STORE CONSENT [ARTICLE 28](#)

- › Developers may check the API to see if a customer has revoked their consent

GATHERING PARENTAL CONSENT [ARTICLE 8](#)

- › The ConsentCheq Privacy Dashboard facilitates both child and parental activity
- › API allows real time verification of parental approval for each session

INFORMING CUSTOMERS OF DATA BREACH [ARTICLE 34](#)

- › The ConsentCheq Developer Dashboard automates notification of identified data subjects in the event of a breach

PROVIDE ACCESS TO A COPY OF THE PERSONAL DATA UNDERGOING PROCESSING [ARTICLE 15](#)

- › The ConsentCheq Privacy Dashboard gives data subjects an option to fix any incorrect personal data

PROVIDING THE "RIGHT TO RECTIFICATION" ARTICLE 16

- › The ConsentCheq Privacy Dashboard gives data subjects an option to fix any incorrect personal data

PROVIDING THE "RIGHT TO DATA PORTABILITY" ARTICLE 20

- › The ConsentCheq Privacy Dashboard allows a data subject to request their personal data in a machine-readable form (available 3Q16)

PROVIDE THE "RIGHT TO OBJECT TO PROFILING" ARTICLE 21

- › The ConsentCheq Privacy Dashboard allows a data subject to express their desire not to be part of profiling, while still giving their consent for processing their data normally (available 3Q16)

PROVIDE THE "RIGHT TO BE FORGOTTEN" ARTICLE 17

- › The ConsentCheq Privacy Dashboard allows identified data subjects to revoke their consent and instruct the data controller that all their personal data is deleted

GENERATE REPORTS TO COMPLY WITH SUPERVISORY AUTHORITIES REQUESTS ARTICLE 53

- › The ConsentCheq Developer Dashboard allows reports to be generated to satisfy supervisory authorities requests
- › Reports demonstrate compliance with consent by data subjects who identify themselves as well as those who don't choose to identify themselves
